IDEAs in Action Curriculum Updates

The new IDEAs in Action website is available at https://ideasinaction.unc.edu/. This deadline applies to all undergraduate course proposals (numbered 50-699) and undergraduate program proposals (majors, minors, concentrations). Curriculum proposals will be reviewed during the 2021-22 academic year and implemented in fall 2022. All changes should be submitted in CIM.

First-Year Launch Updates: Fall 2022

If your request to add the FY-Launch designation to an existing course was approved in CIM, you may now schedule a First-Year Launch section of that course in Fall 2022. Please schedule them in ConnectCarolina using section numbers 01F – 99F. Please note: approval to add the FY-Launch designation in CIM to a course means that you now have the option to schedule both standard sections of the course (section numbers 001-299) <u>and</u> First-Year Launch sections (section numbers 01F-99F).

The First-Year Launch Review Committee met last week to review new FY-Launch proposals in CIM. Associate Dean Li-ling Hsiao is leaving notes and follow-up items for departments through CIM workflow. Check CIM to look up the status of your FY-Launch proposal.

New: Revised Undergraduate Registration for Spring 2022

The Office of the University Registrar and the Center for Operational Excellence have been working on improving the equitability and efficiency of the undergraduate registration appointment system for the last several years. The revised system will be in effect for the spring 2022 registration period. More information was shared at the September Student Services Managers meeting and over the Scheduling Officers' listserv. Additional information is now available on the Registrar's website. Resources for students, faculty, and staff include a Registration Guide and a FAQ. Spring 2022 registration will begin for undergraduate students on Monday, 10-25-2021.
