## **GENERAL CURRICULUM NEWS**

### **2022-2023 Catalog Editing**

The 2022-2023 Catalog will be published on 06-01-2022. There are still some Catalog pages and CIM-Program proposal changes pending review by departments and schools. To see if your department or school has any pending Catalog pages or CIM-Program proposals in workflow, follow these steps:

1. Login to **Pages Pending Approval**: <https://nextcatalog.unc.edu/courseleaf/approve/>
2. In the **Your Role** dropdown menu, check to see if your department/school code appears in the list (e.g., LING, SOE). If it does, you have pending items. The list may include SSM roles, curriculum committee roles, or chair roles.
3. When the role is selected (e.g., PLAN CAT Approver), pending Catalog and CIM proposals will appear below. You have the option to Approve, Edit, or Rollback.

If Catalog pages are not approved by Wednesday 05-04-2022, the Office of Undergraduate Curricula will advance the page on your behalf, with the edits as listed.

**Reminder: Class Features Tool for Summer & Fall 2022**

Instructors are encouraged to utilize the [Class Features tool](#) in ConnectCarolina to provide students with additional information about their summer & fall 2022 courses. To use the tool, log into [ConnectCarolina](#) and select "My Schedule." You will see the "Class Features" link for each course you are scheduled to teach. Copy-over functions and departmental proxies are available to ensure the process is efficient each semester. ### IDEAs in Action Curriculum, Fall 2022 Updates

#### Triple-I:

- The [Fall 2022 Triple-I Course Offerings](#) are published on the IDEAs in Action website. The listing includes course titles, descriptions, meeting patterns, and instructor bios.
- To search in Connect Carolina, use the **FY-TRIPLE** Gen Ed attribute code.
- Seats are limited to incoming fall 2022 first-year students (and incoming fall 2022 transfer students with fewer than 24 credit hours). Current students are restricted from enrolling in these classes.
- Students must register for BOTH the 3 credit Triple-I class and the corresponding Data Literacy 1-credit class, for a total of 4 credits.
- All seats are reserved for the first-year pre-registration process using the FYPR reserve capacity.

#### College Thriving:

- Over 170 sections of [College Thriving](#) will be offered in the fall! Sections are capped at 19 students.
- To search in Connect Carolina, use the **FY-THRIVE** Gen Ed attribute code.
- Seats are limited to incoming fall 2022 first-year students (and incoming fall 2022 transfer students with fewer than 24 credit hours). Current students are restricted from enrolling in these classes.
- All seats are reserved for the first-year pre-registration process using the FYPR reserve capacity.

#### **First-Year Seminar/First-Year Launch:**

- Over 90 FY-Seminars & FY-Launch classes will be offered in the fall! The [Fall 2022 FY Seminar/Launch offerings](#) are published on the IDEAs in Action website.
- To search in Connect Carolina, use the **FY-SEMINAR** and **FY-LAUNCH** Gen Ed attribute codes.
- Seats are limited to incoming fall 2022 first-year students (and incoming fall 2022 transfer students with fewer than 24 credit hours). Current students are restricted from enrolling in these classes.
- All seats are reserved for the first-year pre-registration process using the FYPR reserve capacity.

#### **First-Year Pre-Registration Process**

The Office of Undergraduate Curricula, in partnership with the Registrar, will begin to pre-register incoming first-year students into up to two First-Year Foundations classes on Monday, 05-16-2022. The following First-Year Foundations have seats reserved for this process: Triple-I, FY Seminar, FY Launch, College Thriving, some ENGL 105/i sections, and some Romance Studies language sections. This process will be completed on 06-15-2022, prior to incoming FY registration sessions, which begin in July. #### **Transfer Credit Reevaluation Request Peak Season is Here**

Department approvers for the Transfer Credit Reevaluation [eForms](#) in ConnectCarolina will begin to see an uptick in requests this month that typically lasts through August. Incoming transfer students may be

relying on these reevaluations for prerequisite courses and other credit so they can plan their Fall 2022 course schedule.

We understand that many of our approvers (typically the DUS or a department's faculty advisor) may be working less over the summer, but on behalf of students we ask you to process summer requests as soon as you are able, clear requests prior to any breaks you are taking, and clear all pending requests as soon as possible when returning in August.

Evaluations closed on the last day of classes, Wednesday, 04-27-2022. Reports will be released to instructors approximately one week after the last day of exams, but no earlier than 05-13-2022. Department chairs may request an early release of reports if they are needed prior to this date by emailing [cas\\_evaluations@unc.edu](mailto:cas_evaluations@unc.edu) with a list of courses or instructors they need an early release for.

The SET website information on Instruments in use has been updated to reflect the currently in use instruments. You can review this information [online](#). The College Standard Instrument is used for all courses selected for inclusion in SET. Department Chairs can request changes to their department's additional questions at any time by emailing [cas\\_evaluations@unc.edu](mailto:cas_evaluations@unc.edu) with the request. Changes will be applied to the Fall semester if received before September 1 and the Spring semester if received by February 1. At this time we are unable to make changes during summer terms due to the compressed timeline for evaluation processes.

**Reminder—Spring 2020 Reports Restricted Access:** Spring 2020 reports were released only to instructors and can only be shared with instructor permission. These reports are optional for promotion and merit considerations per [the College's COVID-19 FAQ for instructors from April 15, 2020](#).
