# COMMUNICATION BEYOND CAROLINA (COMMBEYOND)

### Changes for the 2024-2025 Student Cohort

Students in the 2024-2025 Cohort (including First-Year students and Transfer students) will be required to complete the Communication Beyond Carolina (CommBeyond) requirement in the IDEAs in Action curriculum through an approved CommBeyond course (e.g., UNC credit, transfer credit). Students in this cohort will <u>not</u> be able to fulfill this requirement through a Communication Intensive (CI) course from

the previous Making Connections curriculum, as was permitted with the previous two student cohorts. This update was approved by the General Education Oversight Committee (GEOC) on April 5, 2024.

# CURRICULUM PROPOSALS & CATALOG PRODUCTION:

### 2024-2025 Catalog Production Schedule

The 2024-25 <u>Catalog Production</u> schedule began on Thursday, 2-1-2024, with deadlines for department/school <u>editors</u> on 3-15-2024 and department/school <u>approvers</u> on 3-31-2024. Reminder emails were sent following both deadlines. If any pending pages remain in the system, the Catalog Team will administratively push these pages through workflow. The 2024-2025 Catalog will be published on **6-1-2024**.

### CIM-Course and CIM-Program Proposals AY 2023-2024

Thank you to all the faculty and department staff who submitted undergraduate course proposals and program proposals during the 2023-2024 Academic year! The Course Committee reviewed over 300 proposals for new courses, Gen Ed requests, and significant course revisions. The Office of Undergraduate Curricula also processed approximately 400 proposals for miscellaneous course changes (e.g., title changes, course description updates, requisite changes, etc.). The Office also processed over 80 CIM-Program proposals to revise program requirements for majors and minors.

# SYLLABI REQUIREMENT REMINDERS FOR SUMMER AND FALL 2024

### Syllabus Template & Policy Insert

Instructors are encouraged to utilize the <u>Undergraduate Syllabus Template</u> and the <u>syllabus policy insert</u> when preparing their course syllabi. The template contains all required syllabus elements outlined below, and the policy insert contains all required policy statements and is a quick and easy way to make sure your students receive this information. More details are available on the Office of Undergraduate Curricula's <u>Syllabus Guidelines webpage</u>.

### **Required Elements for Syllabi**

As instructors begin drafting their summer and fall 2024 syllabi, we encourage all instructors to confirm the following elements are present in their syllabi (see additional details on the Office of Undergraduate Curricula's <u>Syllabus Guidelines webpage</u>):

- Course information, including course number, section, title, department, and term.
- Course description from the <u>Catalog</u>, or an expanded version.
- Course meeting days, times, and location.

- Instructor information, including name, email address, office hours, and office location.
- Target audience and any requisites.
- Course resources, including any required texts or materials.
- Course-specific student learning outcomes or goals for the course.
- If the course fulfills one or more IDEAs in Action Gen Ed requirements, the instructor should also include the associated Student learning Outcomes (SLOs) in the syllabus, in addition to the course-specific ones. See details in the <u>Catalog</u>.
  - If the course fulfills a Focus Capacity requirement, the course must also incorporate the three Recurring Capacities (writing, presenting, collaborating)
- Course requirements and assignments, including due dates.
- Grading schema, including a grading scale (A-F or Pass/Fail) and grading rubric.
- Course calendar or schedule.
- All required academic and student support policy statements: University Class Attendance Policy, Honor Code, Artificial Intelligence (AI) Use Policy, Syllabus Change Statement, ARS, CAPS, and Title IX statements. Consider using the syllabus policy insert!

# SCHEDULING & REGISTRATION REMINDERS: SUMMER & FALL 2024

### Incoming Fall 2024 First-Year Pre-Registration

The Office of Undergraduate Curricula, in partnership with the Registrar, will pre-register incoming fall 2024 first-year students in up to two First-Year Foundation classes. At the same time, Honors Carolina pre-registers incoming honors first-year students in Honors First-Year Foundations and other appropriate classes. To run the processes successfully, these offices reserved seats for first-year students in certain fall classes, including First-Year Seminar, First-Year Launch, Triple-I, Honors, and some ENGL 105/I and Global Language offerings. Instructors of these classes may notice their seats caps have dropped significantly, but the caps will be raised back up in late-May so that they can be used for pre-registration. Anything left over after pre-registration will be automatically released during July & August incoming first-year registration sessions, along with the other first-year seat reserves.

### Fall 2024 Pre-Registration Timeline:

- Late Feb. early Mar.: OUC/Honors reserved seats in First-Year Foundations and Honors classes
- Apr. late May: First-year students fill out Pre-Registration Survey
- Late-May mid June: Students pre-registered into First-Year Foundations
- July early Aug.: Unclaimed seats from process released during first-year registration sessions

If you need to make changes to a First-Year Seminar or First-Year Launch now that Extended Course Schedule Maintenance is open, please let <u>Ben Haven</u> know. If you need to make changes to your Honors offerings, let <u>Jason Clemmons</u> know.

### Fall 2024 Registration Updates

We are now in Open Enrollment. All continuing and incoming transfer students can enroll in up to 18 credit hours. These students will have access to enroll in fall 2024 classes until 11:59 PM on Friday, 5-31-2024. First-year pre-registration occurs in late-May to mid-June. Incoming first-year student registration appointments run 7-8-2024 through 8-2-2024. Access to enroll in classes will resume for continuing and transfer students on 8-5-2024. #### **Class Features Tool for Summer & Fall 2024**

Instructors are encouraged to utilize the <u>Class Features Tool</u> in ConnectCarolina to provide students with additional information about their summer and fall 2024 courses. To use the tool, log into <u>ConnectCarolina</u> and select "My Schedule." You will see the "Class Features" link for each course you are scheduled to teach. Copy-over functions and departmental proxies are available to ensure the process is efficient each semester. # **OTHER ITEMS**

#### Student Services Manager (SSM) Meeting: Summer 2024

The next student services managers' meeting will be held on Wednesday, 6-12-2024 from 1:00-2:30 PM on Zoom. The agenda and link will be shared about a week in advance.

#### **Retain Instruction Records for 1 Year**

Per the <u>UNC General Records Retention and Disposition Schedule</u>, records documenting examinations, tests, term papers, and other coursework completed by but not returned to the student **must be retained for 1 year after completion of the course**. The records may be destroyed 1 year after completion of the course for uncontested grade results. For grades that are challenged, the records may be destroyed after resolution of the challenge.

#### Transfer Credit Re-Evaluation (TCRE) Peak Season is Here

Department approvers for the Transfer Credit Re-Evaluation <u>eForms</u> in Connect Carolina will begin to see an uptick in requests this month that typically lasts through August. Current students may be submitting requests as they identify missing prerequisites during registration over the next several weeks, and incoming transfer students may be relying on these re-evaluations for prerequisite and other course credit so they can plan their fall 2024 course schedule.

We understand that many of our approvers (typically the DUS or a department's faculty advisor) may be working less over the summer, but on behalf of students, we ask you to process summer requests as soon as you are able, clear requests prior to any break you are taking, and clear all pending requests as soon as possible when returning in August.

Summer I evaluations open to students on **Thursday, 6-13-24**. The full College SET Schedule is available <u>on our website</u>.

Departments are asked to remind instructors, particularly graduate students, and other first-time instructors to upload a copy of their course syllabus by the end of the first day of the semester (**Wednesday, 5-15-2024**).

The <u>Online Learning Contract Manager</u> (OLCM) tool opened for summer I, summer II, and fall 2024 learning contracts on **Friday, 3-8-2024** (approximately two weeks before the start of summer registration).
